### PNAA Donates to Kababayan Flood Victims

The 11-day monsoon rain has been devastating for our kababayan in the National Capital Region (NCR) and parts of Northern Southern Luzon. Images on the news are heartbreaking and sad. It is an ordeal that has been endured by the Filipinos every year with no foreseeable resolution in the coming years. Lives have been lost and livelihood compromised. Daily lives are altered including simple things like children going to school and having a family meal since most are still in the evacuation centers as their homes are still under flood waters. Many rely on relief goods from the good hearts and kind generosity of others.

PNAA has been an active supporter for such calamity in any way that it can reach out and lend a hand. \$5,000 was donated to two US-based foundations (to

maintain its tax exempt status) namely, ABS-CBN Foundation and PhilDev of Ayala, both receiving \$2,500 each. Past collaborations with these foundations have been fruitful both ways as they have continuously supported PNAA. Fund spending reports will be provided as soon as they are available and will be posted on our website for members.

#### OFC Secretary Nicolas Intervenes on PRC Ruling on Foreign Medical Missions

PRC Ruling requiring increase on the payment of processing fee and issuance fee of Special Temporary Permit ID and liability insurance for healthcare providers has caused the cancellation of several medical missions. While it is important to monitor medical missions to assure appropriate care to our countryman, well organized and compliant medical missions were affected negatively by this ruling.

The Legislative Committee, chaired by Germina Rio convened four well-organized PNAA medical mission groups and sent a series of well thought

of questions to the Philippine Regulatory Commission (PRC) Officer-in-Charge of Project Management Division, Marie Del Rosario-Apattad for their August 13, 2012 meeting. Due to the monsoon flooding, the meeting was cancelled.

In an e-mail sent to PNAA, Imelda Nicolas, Secretary of the Commission of Filipinos Overseas (CFO) articulated her communication with PRC and requested immediate suspension of the moratorium on the following provisions related specifically to the conduct of foreign humanitarian medical missions to the Philippines. This

was supported by the Secretary of the Department of Health (DOH), Enrique T. Ona.

Secretary Nicolas is requesting to "advise" PNAA chapter constituents and other medical missioners NOT TO CANCEL any of their scheduled medical missions to the Philippines and to ask them to wait, if possible, for the first week of September when the PRC Board will make a decision on a moratorium or suspension of the ruling.

An appeal to implement our social action/commitment to sustain the needs of our kababayans.


- 1. Chapters with status 501c(6) like PNAA can only donate within US based foundations and is not tax deductible (this is IRS regulation).

#### Overview of the Secretary's Global Diaspora Forum (GDF)

- Started in May 2011 as an engagement strategy to achieve common goals in both foreign policy and development efforts within the diaspora communities
- GDF represents the diversity and strength of America and is the premier gathering of the diaspora community in the USA
- GDF discusses, brainstorms, and partner on innovative projects that will benefit and have a positive impact on the country of origin of the diasporan communities.
- The State Department and USAID together with the Migration Policy Institute is the voice and medium of the Global Diaspora Forum
- Dr Rey Rivera, Vicky Navarro and May Mayor represented the PNAA at the inaugural GDF in May 17-19, 2011.
  - Vicky Navarro was a panelist for the Diaspora volunteerism aspect of medical missions
  - May Mayor was a panelist for best practice of the "teach back-give back" program of PNAA Balik Turo launched in 2006-2008

#### International Diaspora Engagement Alliance

IdEA - harnesses the global connection of diaspora communities to promote sustainable development for their countries of origin.

#### IdEA promotes the following five core modes of diaspora engagement around the world:

- 1.) ENTREPRENEURSHIP: Support diaspora entrepreneurship in investing and building sustainable enterprises as well as stimulating trade in countries of origin.
- 2.) DIPLOMACY: Support the role of diasporas in diplomacy, advocaccy, and peace building via nontraditional media such as sports, arts and culture.
- 3.) VOLUNTEERISM: Encourage the proliferation of platformsthat facilitate diaspora volunteerism in countriess of origin.
- 4.) INNOVATION: Foster diaspora innovation in communication and information technologies in order to enhance and deepen engagement.
- 5.) Philanthropy: Cultivate diaspora giving in areas of education, health, nutrition, and disaster relief in countries of origin.

#### Prime Examples: EduPAY- Philippines


- Maximizing the development impact of migrant remittances-Lead Investigator: Dean Yang of the University of Michigan
- \$98,409 | The Philippines | Stage 1
- THE OPPORTUNITY: Remittances from migrants are among the largest financial flows
  to developing countries. In 2009, they amounted to \$307 billion—an amount roughly twoand-a-half times larger than foreign aid flows. However, little is known about how the
  development impact of these funds can be maximized.
- THE PROJECT: Researchers from the University of Michigan, the World Bank, Italy, and the Philippines, in collaboration with a major Philippine bank remittance channel and a respected Philippine education NGO, will pilot a financial innovation called EduPay, and use a randomized control trial to rigorously test its impact. This new facility will allow overseas Filipinos to pay educational institutions in the Philippines directly from overseas, without channeling the funds through a relative or other "trustee." The system allows sponsors to monitor the performance (i.e. grades and attendance) of the sponsored student.
- PROJECTED COST-EFFICIENCY: Prior evidence suggests that remittances may have greater long-run development impact when migrants are given more control and monitoring over how the funds are used by recipients. This project will test EduPay's impact on remittance volume, the propensity to finance the education of school-aged children, school attendance and performance.

#### Global Diaspora Forum - Next Steps for PNAA

- PNAA needs to educate itself on what's out there in terms of grants, funding streams, and possible projects that can be worked on with other diasporan communities.
- Need to enhance PNAA communication and information technology savvy in social networking such as twitter, facebook and othet platforms used by other diasporan communities to get their message out there.
- Build awareness within our Filipino community that there is marketplace called IdEA specially for PNAA entrepreneurs, innovators and philantrophy.
- Need to be at the table, as in representation, at Global Diaspora Forum events convened by State Departmen or USAID
