DREAM Act 2012

On Friday, June 15, 2012, President Obama announced a major shift in immigration policy enforcement by ordering the Department of Homeland Security (DHS) immediately halt deportation efforts against young people who were brought into the country as minors. While the President's directive is not technically a law passed by Congress, it does have the practical effect of granting relief to potentially countless thousands young people across the nation. The policy is intended to alleviate the hardship caused to individuals commonly referred to as "DREAMers" after the original legislative act The DREAM ACT (Development, Relief, and Education for Alien Minors Act) first 4. proposed in 2001. Under President Obama's

administrative order, DHS is to exercise its "Prosecutorial Discretion" to grant "Deferred Action" to an eligible individual who can demonstrate that he or she:

- Came to the United States under the age of sixteen:
- 2. Has continuously resided in the United States for at least five years preceding June 15, 2012 and was present in the United States on June 15, 2012:
- Is currently in school, has graduated from high school, has obtained a general education (GED) certificate, or is an honorably discharged veteran of the Coast Guard or Armed Forces of the United States;
- 4. Has not been convicted of a felony offense, a significant

misdemeanor offense, multiple misdemeanor offenses, or otherwise pose a threat to national security or public safety;

5. 5. Is not above the age of thirty.

If you or your family and friends fall in this category please contact your immigration lawyers or get information from the nearest Philippine consulate, or community groups offering programs to help eligible DREAMers. (Click here for PATH For DREAMs Program offered in New Jersey)



Title:

Policies and Guidelines in the Conduct of Foreign Surgical and Medical Missions (FSMM) in the Philippines

STATEMENT OF CONCERN:

The proposed guidelines in the "Implementation of Modernization Act of 2000" issued by the Professional Regulation Commission (PRC) on June 21, 2012, has created a massive negative response from individuals and organizations involved in medical missions in the Philippines. The proposed changes under Section 5 (Fee) and Section 17 (Liability Insurance of a Natural Person under a Special Temporary Permit) were found to be particularly burdensome by missioners who are volunteers providing needed charitable health care services and resources for the poor in the Philippines.

The objections raised by individuals and organizations in the US who are engaged in medical missions in the Philippines center on two major issues:

- 1. The proposed guidelines were unilaterally developed and imposed without consultation or input from individuals and groups affected by the guidelines.
- 2. The increase in fees from Php 1,250.00 (~\$30) to Php 11,000 (~\$262) required for each foreign health professional (doctors, nurses, dentists) was deemed unreasonable and without adequate documentation on how the increase was calculated.

It is imperative that any changes in guidelines consider the costs incurred by volunteers who are motivated by humanitarian interests for their kababayan. Each volunteer:

- a. Shoulders the cost of roundtrip airfare, lodging and food.
- b. Forgoes additional income from work and uses vacation or paid time off (PTO) to participate in these missions
- c. Personally contributes and solicits donations to provide free medications and equipment which are given free-of-charge to patients and/or hospitals

- e. Provides education and consultation for patients, health professionals and organizations in the Philippines

The economic downturn is experienced globally and any additional requirements will discourage volunteers and organizations that provide humanitarian services without expectation of any financial support from the Philippine government.

Indeed, the proposed changes have resulted in several cancellations of planned missions to the Philippines. The health and well-being of Filipino communities will be impacted by the cascading effects of these unresolved issues.

BACKGROUND:

Foreign Surgical and Medical Missions (FSMM) are activities where surgical and medical care is provided by local and foreign organizations upon the initiative/requests of various local government units and groups. They are primarily undertaken in underserved areas and communities with the goal of providing assistance to the needy as a professional humanitarian endeavor. They may also provide continuing medical education (CME) and opportunities for professional advancement of healthcare professionals sharing knowledge, skills and technology with their local counterparts.

On June 21, 2012, the Professional Regulation Commission issued Resolution No. 2012-668 with new guidelines in implementing Section 7, Paragraphs (J0, (L), and Section 16 of the Republic Act No. 8981 - "PRC Modernization Act of 2000." This Act contains provisions pertinent to the professional regulatory laws, general agreement on trade in services and other international agreements on the practice of foreign professionals in the Philippines.

On August 17, 2012, Commission on Filipinos Overseas Secretary Imelda Nicolas organized a meeting with PNAA and CFO; and a few hours later with WHO and PRC. This was followed by the announcement by PRC Chairperson, Teresita Manzala immediately suspending the implementation of Sections 5 and 17 of the PRC Resolution.

In effect, medical missions in the Philippines will continue to be governed by the rules in the existing Joint Administrative Order (A.O.) No. 2009-0030 governing medical missioners since 2009.

STATEMENT OF POSITION:

The Philippine Nurses Association of America recognizes the need to integrate the joint efforts of the Philippine Department of Health (DOH), the Department of Interior and Local Government (DILG) and the Professional Regulation Commission (PRC) to oversee the conduct of FSMM, facilitate issuance of Special Temporary Permit to Practice to missioners and to ensure proper supervision and monitoring of FSMM in the country to ensure the safety and to protect the welfare of the Filipino people. PNAA expects all of its members and collaborative organizations participating or organizing FSMM to adhere to these regulations.

RECOMMENDATIONS FOR ACTION:

The Philippine Nurses Association of America stands together with the DOH, CFO, DILG and PRC to:

- Protect the quality and standards of care by ensuring that only qualified medical and paramedical health workers, with a valid/current license from the country of origin and authenticated by the Philippine Embassy or Consulate Office in the country of origin shall perform the appropriate medical and surgical procedures
- 2. Protect human rights of the underserved and underprivileged citizens of the Philippines
- Ensure that all medicines, supplies, reagents as well as medical and surgical services provided by PNAA members and collaborators during the mission are provided at no cost to the beneficiaries
- 4. Develop the "Handbook on Best Practices, Policies and Procedures on Foreign Surgical and Medical Missions in the Philippines" with the Commission on Filipino Overseas (CFO) which will be made readily accessible electronically and used to orient all missioners prior to the mission
- Assist in expediting the processing of applications and special permits for PNAA member missioners and compliance with PRC rules





August 18 & 19 - Philippine Fiesta at the Meadowlands


